# Information for Schools

The Program "Greek Language Program and Mediation Services for Minor Third- Country Nationals" (TCNs) («Μαθαίνω ελληνικά!») is addressed to students attending a primary education class during the school year 2020 - 2021 and 2021 - 2022.

The program is being implemented by the Research Centre CARDET, in cooperation with the Frederick University and the Advisory Company INNOVADE, in collaboration with Cyprus Ministry of education, culture, sport and Youth.

It is funded by the Migration and Asylum Fund for the Integration of the Republic of Cyprus.

The program is specifically designed to meet the needs and expectations of TCN students. Through the program students are expected to acquire basic language skills by attending second language classes.

## These skills are:

- Listening and speaking.
- Reading and writing.

\* The specific skills will be taught in alignment with the school curriculum and syllabus and following the Common European Framework of Reference for Language Levels.

## Program Implementation

- The courses will be offered on four (4) levels of language instruction (A1/A2 και B1/B2. The courses will be implemented in all government-controlled areas of the Republic of Cyprus at **specific schools**.
- The total duration of each round of courses is 60 hours.
- There will be four Round of Courses
- The courses will be offered at the same schools that students are attending.
- Participants will be offered a snack at the beginning of each lesson, upon completion of the school day, 2 or 3 times a week for 1.5 hours each time.
- Each child is entitled to attend the final exam, after attending to more than 60% of the course.
- Children who will successfully complete the course will be rewarded.

## The benefits for the children-participants in the program:

Language skills are essential for the smooth integration of TCN children in the school environment and in Cypriot society in general, as the development of language skills facilitates the daily activities of students and improves their integration skills into society. In addition, the risk of social exclusion is minimized. The students will get acquainted with the everyday life and culture of the Cypriot society.
