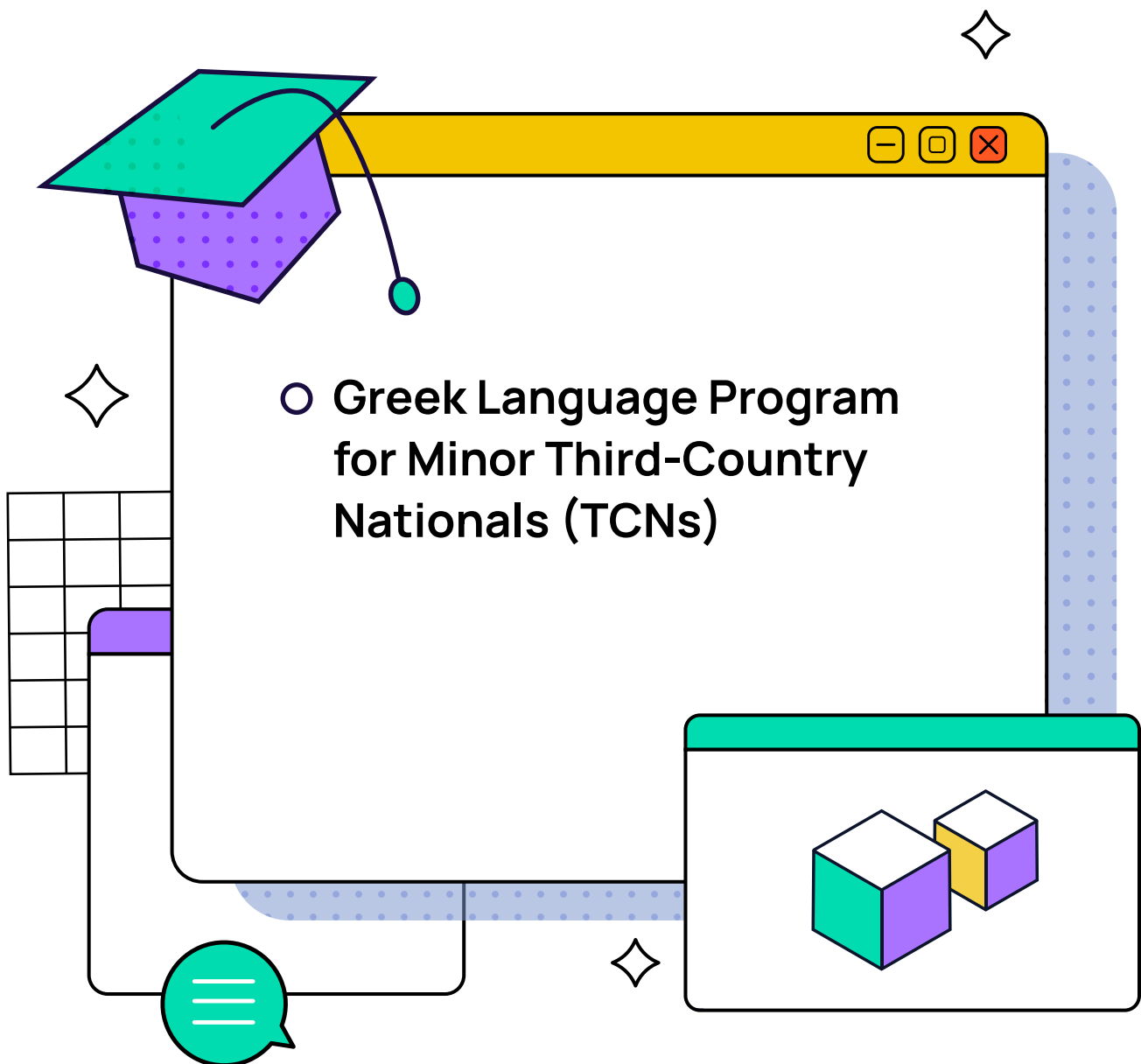

INFORMATION FOR SCHOOLS

Program Overview:

The **Greek Language Program for Minor Third-Country Nationals (TCNs)** («Μαθαίνω ελληνικά!») is available to students in **primary and secondary education** during the 2026–2027 school years.

The program is implemented by the **Research Center CARDET**, in partnership with **Frederick University** and **INNOVADE**, and collaboration with the **Cyprus Ministry of Education, Culture, Sports, and Youth**.

This program is specifically designed to address the needs and expectations of TCN students. Participants will develop essential skills in:

- **Listening and speaking**
- **Reading and writing**

* These skills align with the school curriculum and the Common European Framework of Reference for Languages (CEFR).

Program Implementation Details:

- Courses will be delivered at four levels: **A1, A2, B1, and B2**.
- Classes will take place in schools located in government-controlled areas of the Republic of Cyprus.
- Each round of courses will last **90 hours (135 periods)**.

Schedule

- Classes will happen **2–3 times a week**, lasting **1 – 5 hours per session**, after the school day ends.
- **Snacks** will be provided at the beginning of each session.



Attendance and Rewards

- Students must attend at least **60% of the course** to be eligible for the final exam.
- Successful participants will receive rewards.

The benefits for the children participants in the program:

Language skills are crucial for the smooth integration of TCN children into the school environment and Cypriot society. Developing these skills will:

- Facilitate daily activities and improve social integration.
- Minimize the risk of social exclusion.
- Familiarize students with the culture and everyday life of Cypriot society.
